## 1. COMPANY INFORMATION

# 2. APPLICABILITY

- 2.1 These terms and conditions apply to all offers, orders, and agreements between Be Your True Color (hereinafter: "provider") and the customer regarding the online program "The Journey to Your Future" (hereinafter: "the program").
- 2.2 By placing an order, the customer declares to agree with these terms and conditions.
- 2.3 Deviations from these terms are only valid if explicitly agreed upon in writing.

#### 3. THE OFFER

- 3.1 The program "The Journey to Your Future" is an online self-study EFT program (Emotional Freedom Techniques).
- 3.2 The program consists of digital content such as videos, audio files, PDF documents, and/or other digital study materials.
- 3.3 The price of the program is \$127.00 (excluding any transaction fees from the payment provider).
- 3.4 All amounts include VAT, unless stated otherwise.

#### 4. FORMATION OF AGREEMENT

- 4.1 The agreement is formed at the moment the customer has placed the order, and payment has been completed.
- 4.2 After successful payment, the customer receives a confirmation email with access to the program.
- 4.3 The customer is responsible for providing a correct email address. The provider is not liable for problems arising from an incorrectly provided email address.

## 5. PAYMENT

- 5.1 Payment is made via the payment methods offered on the website (Plug & Pay).
- 5.2 The full amount of \$127.00 must be paid in one transaction.
- 5.3 After receipt of payment, the customer receives immediate access to the program.

## 6. DELIVERY AND ACCESS

- 6.1 The program is delivered digitally via an online learning environment/platform.
- 6.2 The customer receives login credentials by email after payment.
- 6.3 The customer has **lifetime access** to the program and all associated materials.
- 6.4 The provider reserves the right to modify the platform or technical design of the program, provided that the content and accessibility for existing customers remain guaranteed.
- 6.5 The customer is responsible for a working internet connection and suitable equipment to access the program.

## 7. RIGHT OF WITHDRAWAL

- 7.1 Because the program consists of **digital content that is immediately accessible after purchase**, the statutory right of withdrawal of 14 days expires.
- 7.2 By completing the purchase, the customer **explicitly gives permission** to immediately access the digital content and declares to agree with the **waiver of the right of withdrawal**.

7.3 This is in accordance with Article 6:230p paragraph 13 of the Dutch Civil Code.

#### 8. INTELLECTUAL PROPERTY

- 8.1 All rights relating to the program, including but not limited to copyrights, trademarks, and other intellectual property rights, belong to the provider.
- 8.2 The customer is not permitted to:
  - Copy, distribute, resell, or make public the program or parts thereof;
  - Share login credentials with third parties;
  - Use content from the program for commercial purposes without written permission.
- 8.3 The customer acquires a non-transferable, personal right of use to follow the program.

## 9. PRIVACY AND DATA PROCESSING

- 9.1 The provider processes personal data in accordance with the General Data Protection Regulation (GDPR).
- 9.2 The customer can consult the privacy statement at www.beyourtruecolor.com.
- 9.3 Personal data is used exclusively for:
  - Delivering the program;
  - Communication with the customer;
  - Improvement of services.
- 9.4 Data is not shared with third parties, except when necessary for the execution of the agreement (for example, the payment provider).

#### 10. LIABILITY AND DISCLAIMER

- 10.1 **Not a medical treatment**: The program "The Journey to Your Future" is **not a substitute for professional medical, psychological, or psychiatric care**.
- 10.2 EFT (Emotional Freedom Techniques) in the course The Journey to your Future is a self-help technique that can contribute to personal development and well-being, but is not a recognized medical treatment.

- 10.3 **Personal responsibility**: The customer is personally responsible for the application of the techniques provided and the consequences thereof.
- 10.4 **For serious complaints**: Customers with serious psychological or physical complaints are strongly advised to seek professional help from a recognized healthcare provider.
- 10.5 **Limitation of liability**: The provider is not liable for direct or indirect damage resulting from the use of the program, unless there is intent or gross negligence on the part of the provider.
- 10.6 **Technical issues**: The provider strives to keep the program available at all times but cannot guarantee that the platform will always be available without errors and interruptions.
- 10.7 **Results**: The provider does not guarantee specific results. Results are individual and depend on personal commitment and circumstances.

#### 11. COMPLAINTS

- 11.1 Complaints about the program can be submitted via info@beyourtruecolor.com.
- 11.2 The provider will respond to the complaint within 14 days of receipt.
- 11.3 If a complaint is not resolved satisfactorily, the customer can turn to a dispute resolution committee or an independent mediator.

#### 12. AMENDMENT OF TERMS AND CONDITIONS

- 12.1 The provider reserves the right to amend these terms and conditions.
- 12.2 Changes take effect 30 days after announcement on the website.
- 12.3 Changes do not apply to agreements already concluded, unless legally required.

## 13. APPLICABLE LAW AND DISPUTES

- 13.1 **Dutch law** applies to these terms and conditions and all agreements between provider and customer.
- 13.2 Disputes will preferably be resolved through mutual consultation.
- 13.3 If no solution is reached, disputes are subject to the **competent court in the district** where the provider is established, unless the law dictates otherwise.

## **14. FINAL PROVISIONS**

- 14.1 If one or more provisions of these terms and conditions prove to be null and void, the remaining provisions remain in full force.
- 14.2 In cases not covered by these terms and conditions, a decision will be made in the spirit of these terms.
